Reference to Policy handout: took out policies that were in current bylaws when amending them; also gleaned from any other sources, like web site, brochure, etc...

Should have a policy statement to complement the bylaws Tentative discussion; tabled to next meeting for discussion when it is scheduled

## E. New Business

Budget
 Reviewed Process: ask for needs, created subcommittee on budget; put together budget request for last meeting;

Handout of Proposed 2011 BCGS budget includes beginning balance unlike in past years

concern expressed regarding presentation of budget; this is the way the program generates the report; need to focus on what we have before us regarding \$\$\$

Total expenses = \$2,146

Total income including beginning balance of \$3,700 = \$5,299

True income without bank balance = \$1599

difference between true income for year - beg balance - expenses = \$547 deficient spending for the year

note Newspaper indexing CD's a one time deal only = \$200 reduce cost of newsletter?

Discussion of Do we want to deficit spend? Comfortable place to maintain bank balance? past years \$3000 based on ?????; cushion for unexpected expenses aka rainy day fund; use for one time thing not normal operating expenses.

look at reducing normal operating expenses - therefore, we are short \$347; putting \$ into programs is an investment to increase membership - long range investment;

How can we generate more income? takes efforts, perhaps need to publicize more to end with the long term result;

Add publication \$ here? focus on how we can increase income not just reduce expenses....

look at numbers of papers left at libraries - over distributing? is if bringing in more members? If they can get newsletter, come to programs for free, why join?? except to check out books...need to make membership valuable.

Brainstorming ideas??? raise price of library use...

Looked at newspaper mailing labels to see who should really be getting them...complementary? organization exchanges? left at library still there the next month...individuals can get digital, then print them out themselves.

How many copies 10 @ Philo lib. / 10 @ corvallis lib / 10 museum / 5 chamber of commerce

Nickel & dime this newsletters cost to death...need more information, then decide

21 individuals sent/ 14 organizations 35 distributions cost .80 per issue + postage for ones mailed \$14.40 to provide to each addresses (including the drop off??)

Table until we have more info -Bill - contact people who get by mail; Gene - count # over distribution organizations will still receive & lifetime (charter) members

Query income? \$10 per request dig up policy in prior newsletter? also on web site? find & add to policy to be voted on....some would like to see queries included in newsletter again...could be fundraiser...published...have been tried before...continued discussion of publicizing names and researchers...

raise the price of library - currently 1st time free, next time \$1...how do you enforce?

easier...just charge fee for nonmembers ever \$5 fee each time...add to list of

charge nonmembers for speakers? discuss next time whether to add to policy

turn attention to what we can cut to make balance budget...

request to modify look of budget; can't change with this program Must approve budget now or not approve today

question regarding making \$ off of book sale but it floats. We make about 20% profit. recommend reducing book purchases to \$100; if there is a book that we absolutely need we can dip into the rainy day fund. members can purchase and society will pay

1/2 when it comes to library approved \$100 for book purchases

deficit now \$247

cut \$100 off newsletter - cut 8 and that will cover it

fluidity of book publishing....can approve

Raffle ticket amount may be wrong...Susan recalled larger # when she told folks \$ went to speakers

Raffle ticket earnings are under Library with income \$422 Dedicating \$\$ for book purchases is just the way it was Discussion of where to list what.

Lib: Book sales, misc.; donation;

Line items: Dec party & auction; raffle tickets, thrift shop sales

Give the adjustments mentioned above: Shift some items from library to line items reduce book purchases by \$100

Is there a motion to approve budget as adjusted: vote approved
