Insurance: Danell reported the findings given to her by Ken Bielman. A consultation with agents and Barker-Uerling Insurance in Corvallis led to a recommendation that the Society consider general liability insurance only and that the Benton County Historical Society add BCGS as an "additional insured" to their policy at the cost of \$20-50 per year. The cost of insurance to replace the library is very expensive and not feasible under the current budget.

A motion was made, seconded and passed allowing the BCGS Board to petition the Historical Society Board to be added to their policy as an additional insured.

BCGS will pay the additional premium.
